Chairs Murray and Cole, Vice-Chair Collins, Ranking Member DeLauro, Chairs Merkley and Simpson, and Ranking Members Murkowski and Pingree,

On behalf of the undersigned Appalachian National Scenic Trail (ANST) Maintaining Clubs (A.T. Clubs), we write to urge the inclusion of appropriate financial support for the public lands and the communities that are currently recovering from the impacts of Hurricane Helene in a supplemental disaster appropriation. As members of these communities and stewards of national park and forest lands, we know that the health of both are intertwined. As current, annual Congressional appropriations did not cover all the necessary work prior to this disaster, full recovery will not be possible unless additional, appropriate funding is provided.

Our public lands are a legacy conserved by our forebearers for our descendants. They provide clean water, air, recreational and economic opportunities, and help us understand who we are as a nation. The ANST was protected by Congress "to provide for the maximum outdoor recreation potential and for the conservation and enjoyment of the nationally significant scenic, historic, natural, or culture qualities..." of the Appalachian Mountain region. Each of our organizations are long-time partners of the National Park Service and the USDA Forest Service. While each of us are local NGO management partners of the Appalachian National Scenic Trail (ANST), several of us have responsibilities beyond trail maintenance and stewardship of the ANST Corridor. Our individual A.T. Club members have decades of experience. As organizations, many of us were present for the inception of the "A.T. Project" and our predecessors built the original Trail nearly 100 years ago. It is our honor and responsibility to serve the public, including in speaking up on the importance of this issue.

From the north Georgia communities of Dahlonega and Blairsville through Marshall, Hot Springs, and Boone, North Carolina, to Erwin and Roan Mountain, Tennessee, to southwestern Virginia communities of Damascus and Pearisburg, our communities rely on public lands to be engines of opportunity. Without dedicated appropriations from Congress to support their recovery, neither the lands nor our communities will be able to recover from the hurricane as they need to. We say this with confidence as we have operated the ANST on these lands for decades and know the resources our agency partners need to support our work and to uphold the public trust for all Americans.
